Start planning for fall worksite flu vaccine clinics

Medicare Part D mailing coming in September

Medica will soon mail annual Medicare Part D creditable coverage (or non-creditable coverage) notices to all fully insured employers and their subscribers and to self-insured customers who have purchased this service. The notices are required by law and are designed to help Medicare-eligible individuals decide whether to retain their current

prescription drug coverage, or to enroll in Medicare prescription drug coverage. Employers must file their notices directly with the Centers for Medicare and Medicaid Services (CMS).
